Dear Chairman Congdon,

We are writing concerning the Indian Point Reuse Study underway by D.L. English Consulting, Inc. We respectfully request that the report include maps that, in addition to buildings and other structures, topography, location of monitoring wells, and proposed on-site storage of spent fuel rods, will also include sensitive environmental areas, electric lines, substations and related interconnection infrastructure, gas pipelines crossing under and near the facility, and any other relevant features that will help us to truly understand the potential for site reuse in the short and long-term.

In that regard, we note the relevance of the Risk Assessment for the Algonquin Pipeline, which crosses beneath and near Indian Point. The information included in the Risk Assessment is essential background for the Reuse Study. Please let us know the status of the Risk Assessment, which was initially commissioned in 2016 and with an expanded scope that was due to be completed more than a year ago.

Dear Governor Cuomo,

I write today to respectfully ask that you release the results of the risk assessment of the Algonquin Incremental Market Pipeline's and its potential effects on Indian Point Energy Center. I am a member of the Indian Point Closure Task Force, thanks to your appointment, and believe that the information in this report would greatly behoove the task force's recommendations moving forward.

A considerable amount of time and thought regarding the closure of Indian Point is the economic impact of the loss of the P.I.L.O.T. in place with Entergy and the municipalities. The re-use of the property on which the power plant currently sits seems an obvious source of potential revenue, should it be able to be re-used. However, I do not think that we can move forward without all possible information.

I recognize that I am not the first person to ask that you release this information, nor is it the first time that I have asked you to release the report. But, we are now in a position of needing to take all information into account to ensure that our discussions are able to take everything into account.
