Dear Honorable Members of the Board:

I respectfully request that your Honorable Board adopt "A LOCAL LAW amending Section 277.504 of the Laws of Westchester County relating to the qualifications of the Board of Plumbing Examiners."

I have been advised that Section 236 of New York State County Law provides Westchester County with the authority to create a Westchester County Board of Plumbing Examiners to assume all licensing duties with respect to the licensure of plumbers and to provide for their duties and responsibilities in accordance with local law. Pursuant to said authority, Westchester County created the Westchester County Board of Plumbing Examiners in 1995 consisting of ten members.

Currently, there are certain requirements and qualifications that were originally determined to be necessary in 1995, which have made the appointment process of qualified individuals to serve on the Board of Plumbing Examiners extremely difficult. In an effort to ease the appointment process while still requiring qualified individuals to serve on the Board of Plumbing Examiners, attached is a proposed local law that, if enacted, would amend the requirements necessary to qualify for appointment. Specifically, the proposed local law would eliminate from the Laws of Westchester County the requirement that an individual must be a Westchester County resident and reduce the number of years from ten to five as an active plumbing code enforcement officials. Notwithstanding, to qualify for an appointment as a plumbing code enforcement official, individuals are still required to possess either a master plumber's license or a certificate of competency—both of which would require, at a minimum, nine or ten years' experience as specifically set forth in Section 277.506 of the Laws of Westchester County in addition to the five years as an active plumbing code enforcement official. These proposed amendments comply with New York State County Law which authorized Westchester County to create the Board of

Plumbing Examiners and conforms with New York State Public Officers Law which permits public officers to be appointed if such person resides in the state of New York.

Additionally, and as you know, your Honorable Board must comply with the requirements of the State Environmental Quality Review Act ("SEQRA"). The proposed Local Law does not constitute an action as defined under the SEQRA regulations, 6 NYCRR Part 617.2(b). Therefore, pursuant to SEQRA, no environmental review is required.

Therefore, in light of the aforementioned, I strongly recommend that your Honorable Board adopt the proposed Local Law.

Your Committee is in receipt of a communication from the County Executive urging the adoption of "A LOCAL LAW amending Section 277.504 of the Laws of Westchester County relating to the qualifications of the Board of Plumbing Examiners."

Your Committee has been informed that Section 236 of New York State County Law provides Westchester County with the authority to create a Westchester County Board of Plumbing Examiners to assume all licensing duties with respect to the licensure of plumbers and to provide for their duties and responsibilities in accordance with local law. Your Committee is advised that the proposed Local Law does not constitute an action as defined under the SEQRA regulations, 6 NYCRR Part 617.2(b), and therefore no further environmental review is required. Your Committee concurs with that conclusion.

Your Committee, after careful consideration, recommends the adoption of this proposed Local Law.

### RESOLUTION NO. - 2018

RESOLVED, that this Board hold a public hearing pursuant to Section 209.141(4) of the Laws of Westchester County on Local Law Intro. No. \_\_\_\_ - 2018, entitled "A LOCAL LAW amending Section 277.504 of the Laws of Westchester County relating to the qualifications of the Board of Plumbing Examiners." The Clerk of the Board shall cause notice of the time and date of such hearing to be published at least once in one or more newspapers published in the County of Westchester and selected by the Clerk of the Board for that purpose in the manner and time required by law.

### LOCAL LAW INTRO. NO. -2018

A LOCAL LAW amending Section 277.504 of the Laws of Westchester County relating to the qualifications of the Board of Plumbing Examiners.

BE IT ENACTED by the County Board of Legislators of the County of Westchester as follows:

Section 1. Subsection A of Section 277.504 of the Laws of Westchester County is hereby amended to read as follows:

Sec. 277.504. - Board of Plumbing Examiners.

- A. There shall be a County Board of Plumbing Examiners consisting of ten members, who shall be residents of the state of New York [the county] and who shall be appointed as follows:
- 1. Three master plumbers who possess Westchester master plumber licenses and ten years' experience as a plumbing contractor in the plumbing business in the County of Westchester and who are recommended to the County Executive by the Plumbers Task Force. Such candidates shall be appointed by the County Executive subject to confirmation by the County Board of Legislators.
- 2. Two certified journey level plumbers with at least ten years of experience at the journey level in the County of Westchester and who are recommended to the County Executive by the Plumbers Task Force. Such candidates shall be appointed by the County Executive subject to confirmation by the County Board of Legislators.
- 3. Two plumbing code enforcement officials with at least [ten ] five years' experience as an active plumbing code enforcement official employed in Westchester County and each possessing a Westchester County master plumber's license or certificate of competency

who shall be recommended to the County Executive by the Plumbers Task Force. Such candidates shall be appointed by the County Executive subject to confirmation by the County Board of Legislators.

- 4. One member from county government licensed by the State of New York as a professional engineer who shall be appointed by the County Executive subject to confirmation by the County Board of Legislators.
- 5. One member at large representing the general public who shall be recommended to the County Executive by the Chairman of the Board of Legislators. Such member shall be appointed by the county executive subject to confirmation by the County Board of Legislators.
- 6. One member who is employed by a local municipal government department of public works or its equivalent office. Such member shall be recommended to the County Executive by the Chairman of the County Board of Legislators. Such candidate shall be appointed by the County Executive subject to confirmation by the County Board of Legislators.
- 7. Of the members first appointed, two shall be appointed for terms of two years, and three shall be appointed for a term of three years, and five shall be appointed for a term of five years. Their successors shall be appointed for terms of five years from and after the expiration of the terms of their predecessors in office.

Section 2. This local law shall take effect immediately.
