### I. ITEMS FOR DISCUSSION

1. **(ID # 5190) Act – BOND-RGP08-Gen'l Infrs Vehicle Replacement:** A BOND ACT authorizing the issuance of TWO MILLION (\$2,000,000) DOLLARS in bonds of the County to finance Capital Project RGP08- General Infrastructure Vehicle Replacement.
2. **(ID # 4994) Act – BOND-RB117-Mill Rd, Eastchester & New Rochelle:** A BOND ACT authorizing the issuance of up to \$83,000 in Bonds to Finance the Cost of Design of Improvements to Cr #82, Mill Road, in Eastchester and New Rochelle
3. **(ID # 5122) Act – LEGISLATORS JENKINS AND PEREZ: BOND-BPL01-Warburton Riverview Apartments-Yonkers:** A BOND ACT authorizing the issuance of TWO MILLION SEVEN HUNDRED FIFTY THOUSAND (\$2,750,000) DOLLARS in bonds of the County to finance Capital Project BPL01-Warburton Riverview Apartments, Yonkers.
4. **(ID # 5121) Act – LEGISLATORS JENKINS AND PEREZ: IMA-Warburton Riverview Apartment -Yonkers:** An ACT authorizing Westchester County to enter into an inter-municipal agreement with the City of Yonkers whereby the County would finance certain infrastructure improvements and be granted an easement to access said improvements in support of a fair and affordable housing development to be known as

Warburton Riverview Apartments located in the City and accept such property rights.

5. **(ID # 5361) Act – IMA-For-Hire Vehicles-Tuckahoe-DRAFT:** An ACT to authorize the County of Westchester to enter into an inter-municipal agreement with the Village of Tuckahoe pursuant to which the Village, through its police department, will assist the County in enforcing the Westchester County For-Hire Vehicle Law, Chapter 270 of the Westchester County Administrative Code.
  
6. **(ID # 5358) Act – IMA-For-Hire Vehicles-Rye Brook-DRAFT:** An ACT to authorize the County of Westchester to enter into an inter-municipal agreement with the Village of Rye Brook pursuant to which the Village, through its police department, will assist the County in enforcing the Westchester County For-Hire Vehicle Law, Chapter 270 of the Westchester County Administrative Code.
  
7. **(ID # 5360) Act – IMA-For-Hire Vehicles-Tarrytown-DRAFT:** An ACT to authorize the County of Westchester to enter into an inter-municipal agreement with the Village of Tarrytown pursuant to which the Village, through its police department, will assist the County in enforcing the Westchester County For-Hire Vehicle Law, Chapter 270 of the Westchester County Administrative Code.
  
8. **(ID # 5359) Act – IMA-For-Hire Vehicles-Sleepy Hollow-DRAFT:** An ACT to authorize the County of Westchester to enter into an inter-municipal agreement with the Village of Sleepy Hollow pursuant to which the Village, through its police department, will assist the County in enforcing the Westchester County For-Hire Vehicle Law, Chapter 270 of the Westchester County Administrative Code.
