### 1) Oath of Office

Mr. Boykin addressed the audience and took the Chair.

### 3) Election and Oath of Office - Board Vice Chair

On motion of Mr. Johnson, seconded by Ms. Borgia, Ms. Williams name was submitted. With no other nominations made, a long roll call was taken. With a vote of 16-0, Ms. Williams is elected the Vice Chairperson of the Board of Legislators. The Oath of Office was administered by the Honorable Gretchen Walsh. Ms. Williams addressed the audience.

### 4) Election and Oath of Office - Clerk of the Board

On motion of Mr. Williams, seconded by Ms. Parker, Ms. Vanderberg's name was submitted. With no other nominations made, a long roll call was taken. With a vote of 16-0, Ms. Vanderberg is elected the Clerk of the Board of Legislators.

Mr. Boykin announces Ms. Parker as Majority Leader, Ms. Shimsky as Majority Whip, Mr. Testa as Minority Leader and Mr. Burrows as Minority Whip.
