Dear Members of the Town Board,

I am the owner of 246 Old Lake Street, West Harrison, New York. I petition the Town Board of Harrison, New York to approve my request to be removed from the Mamaroneck Valley Sewer District. The property at this address has never had sewer service nor is there any plan (that I am aware of) to ever offer public sewer access.

As you can see from the enclosed county tax bill, my share of the sewer tax is \$547.84 per year, far more than the proposed reimbursement of approximately \$300.00, offered every three years by Westchester County to pump my septic system.

My understanding of the process is that once the town approves my petition, the County Health Department will investigate my request and make a recommendation. I have been advised that this process can take up to nine months, so I am anxious to get the process underway before another year of taxes come due.

Thank you in advance for the prompt attention to this matter.
